A floor plan of the revised design was presented. There were design suggestions – Can it be like the UCSD library, which is small on the ground footprint? Can the windows be clipped at the Plaza level? Can an overhanging roof design be considered?

The plan will be presented at the October CPA meeting. At that time they will provide elevations and an idea of what it will look like.

14. MWWD Point Loma Wastewater Treatment – Presentation on Point Loma treatment. Time certain 7:00 heard at 7:15. Information Item.

Dr. Bertch Director of Metropolitan Wastewater presented information on a handout entitled: "Secondary Treatment Discussion, Community Brief."

4. President's Report - Tim Golba

- 1.) CPC updates There was no meeting in August. There is a COW coming up for those on the Board who did not attend the prior COW training.
- 2.) Armstrong Plans were received last week. The plans were modified to remove the over height retaining walls, but now the structure is over height. Three member of the CPA board attended the Planning Commission hearing on September 6, but the applicant's request for a continuance was granted. The next hearing date is October 12.
- 3.) Bylaws The draft is done with consensus of the subcommittee. There will be a special member meeting to discuss the bylaws. There are 22- 26 deviations that have been identified. Scott Peters has agreed to most of the deviations with a few exceptions. Strike-out/underline version and clean version will be posted to the website. There are two issues: The Board composition with 1`5 elected representatives and 4 appointed (by LJTC, PLJ, BRCC, and LJSA) and the requirements for the effective date of the bylaws. Want a timeline for approval by the City.

7. City of San Diego Planning Department: No report.

8. Keely Sweeney - CD 1 Representative for Council President Peters -

Bylaws – Need to be finished with the bylaws approval by November 20. Suggests that a 60-day time limit for City approval may be okay and t it will be better received than a 30-day limit on the City's approval of the bylaws.

Water Supply – There will be a 30% reduction in water supply within the next year. Brochures from the County Water Authority were handed out. It is recommended to water landscape between 8 PM and 6 AM. Cuyamaca College has a native vegetation garden.

Crash Cushion – There will be work on the repair of the crash cushion on the La Jolla Parkway this weekend. Detailed information is available from her.

Cindy Benner – San Diego Coastal Habitat Coalition under Umbrella of Sierra Club. 320 signatures in support of a year-round rope line at Children's Pool.

Tom Brady – The Children's Pool was a 1931 restricted gift to the City and State by the Scripps. Actions contrary to the gift by the City could put a chill on any donations to the City. Judge Pate will come down with a decision soon.

Anne Cleveland – Seals do not haul out in the summer. It is too hot.

Jim Fitzgerald – Encouraged those present to become informed about what the Community Parking District Board is doing. The recommendations at this time include Paid on Street Parking.

Darcy Ashley – Received a flyer soliciting support for T-mobile installations in the Public Right of Way. Copies were given to the Board.

Mike Costello – If the seals get Children's Pool do we still need a lifeguard station there?

- **Bird Rock Community Council** Joe La Cava reported that there would be a Halloween Safety Meeting at Bird Rock Elementary on September 18 from 6-7 PM.
- UCSD Community Planner Milt Phegley The LJ Light gave a project update. School starts on September 27. There will be 27,500 students including 4100 freshmen. UCSD will reach its capacity for undergraduates within the next several years. In answer to a question there is a pay station in the parking lot by the La Jolla Playhouse.

15. Olivetas Townhomes (7417 Olivetas Avenue – Requested to be heard by full CPA) Approved 4-3-0 at CDP Subcommittee.

Applicant presented project. Letter from the Social Services League was discussed. The League opposed to the colors and the style of the building as compared with the Darlington House (next door neighbor). Mr. LaCava commented on the failure of the motor court to qualify as PDO landscaping. Ms. Lightner requested that a variance be requested for the landscaping requirement if additional landscape is not required. There was a lengthy discussion of the PDO requirements. Motor court was called a "vehicle accessible pedestrian plaza."
