REGULAR MEETING WAS CALLED TO ORDER 4:10 p.m.

1. DRAPER AVENUE CONDOS, 7516 Draper Avenue, PDO Zone 5, Owner/Representative: Joe Astorga. Applicant proposes demolishing an existing 4 or 6 (illegal) unit apartment built in 1932 and constructing a new building with 5, 2story town homes. Project was initially heard on March 19, 2007 at which time the applicant was asked to return with the landscape plan and the color scheme. The landscaping did not meet the Option B requirements for landscaping given by the LJ PDO. The color of the building will be light gray with dark gray trim. The applicant will return with additional information to demonstrate conformance with Option B landscape requirements.
INFORMATIONAL - NO VOTE
2. COCO COVE, 1000 Prospect Street, PDO Zone 1, Owner/Representative: Patrick Ahearn. Previously heard at the March 19, 2007 LJ PDOC. Applicant is considering applying for an off-sale liquor license (Beer, wine and spirits) with a Conditional Use Permit (and possibly on-sale) license and a PROW (public Right of Way Use) permit for two four-tops in font of the building. Food for sale on site will include high quality, prepackaged food and coffee. Committee was concerned with whether or not the proposal is an intensification of use. One way to make sure is to not have the equipment (per Health Department Requirements) to prepare food on site. Committee would like to know where the $10 \%$ of the floor area for alcohol sales would be located. The applicant tried to find parking at 1010 and 1020 Prospect Street. Check trash and delivery situation.
MOTION: The Committee supports an off-sale license for beer, wine and spirits (sales limited to 10\% of the floor area and a maximum of $20 \%$ of the gross sales). Applicant was asked to return with parking, information on the commissary and food preparation and sales or any other requirements related to intensification of use. (Marengo/Wagenseller: 6-1-0) No vote in opposition to the off-sales license.

Marengo: There was an article on the LJTC's page in the Village News entitled "Who's Who and What's What."
