**Minutes

**Meeting Called to order 4:00 pm. La Jolla Rec Center**

**Chair Broido addressed the audience on the purpose of the committee and procedures.**

### **Public Comment**

#### **Frank Lepiane – US Post Office**

Has been a mail carrier on Prospect for many years and wanted to bring to the boards attention that the valet operation has been parking cars on the street. They are presently using two hour limited parking. Board to address a letter to Sunset Valet regarding the issue.

Jack's appears to be conducting the same practices. Letter to be addressed to Ace Parking.

**Sherri Lightner** informed the board that the La Jolla Shores Association appointments to Traffic and Transportation will be Jim Heaton and Todd Lessler with Mark Briodo as alternate.

Discussion as to whether Mark as an alternate could continue on as chair. Bylaws do allow non board members to serve as executive officers.

**Sue Moore** – addressed the traffic problems on La Jolla Village Drive, the speed of traffic, number of accidents and people turning right on the red which is not permitted at this intersection is no longer being enforced.

Chair agreed to write a letter to request additional enforcement

**Oversized Vehicle Ordinance**

Discussion by the board to have La Jolla as a demonstration area for the proposed ordinance. The only concern was that there was not sufficient enforcement for the evening hours and people sleeping in the RVs. The board discussed requesting additional enforcement officers for the evening.

**Via Capri - Joe Dicks** – informed the board that there presently are DIF fees available for the installation of traffic calming measures previously approved by the board. The City will need the consent of the CPA to authorize the use of such DIF funds..

**Motion - TNT Board recommends that the CPA support the expenditure of DIF fees for the implementation of the modified Ts, landscape chokers and landscaping on Via Capri previous approved by the TNT board**
