## UPDATE FROM WEST MUIRLANDS TRAFFIC CALMING SUB-COMMITTEE CHAIR – PAUL METCALF

Due to the number of people in the audience for this item it was heard first.

- P. Metcalf reported that the committee met this morning with the neighbors, Assistant Fire Chief and Gary Pence, City of San Diego. The committee will be meeting again and nothing had been determined as of yet. The main concern of those who came to TNT was that the committee would consider a partial street closure. This has not been discussed by the committee. The committee was informed that W. Muirlands is considered a collector street. No speed humps or closure will be accepted by the City.
- J. Peak and other audience members voiced concerns that other street improvements should be viewed and implemented for traffic calming before a partial street closure is considered. Recommendations such as the installation of sidewalk, posted lower speed limit and enforcement were mentioned.

## PLJ Proposal for the establishment of a LJ Parking Management District; public comments, discussion, receipt of modified proposal (if any) - Promote La Jolla, revisions only

Leslie Wade gave a brief overview of the plan and the revisions based on comments from previous hearings.

Board composition has been revised. Confirmation language regarding the board stated that; confirmation will not be unreasonably withhold and language to limit the implementation of paid on street parking as the last item to be considered after all other options have been explored.

Discussion on the Motion

J. Beaver wanted to make a motion to deny the proposal he has issues with veto power and believes parking meters are going to be installed if approved. Did not believe comments were incorporated. Also believes that PLJ should recluse themselves from any vote on the matter.

Chair – said that he did not believe anyone from PLJ had personal gain and were permitted to vote under Roberts Rules.

- R. Gashemi stated that we have a parking problem and something needs to be done to control what happens this is an opportunity to take this control away from the City.
- Y. Marcum made comments to cooperation and compromise and believed it was time for everyone in the community to work together and cooperate.
- M. Coakley supports the idea put does not support PLJ's proposal. Feels it is not comprehensive enough, she would like to see under utilized parking spaces filled.
- S. Lightner does not think we have a parking problem and believes there would be more buy in if parking meters were removed from the plan.
- C. Patton does not feel that parking meters are the number one focus of the plan. Feel the proposal is the first step to begin the discussion on the issue and look at solutions.

- Y. Marcum pointed out that PLJ heard that parking meters are a concern and incorporated language to the effect that paid on street parking will be viewed by the board as the last resort.
- P. Metcalf maybe the problem is that this district has the wrong name, maybe it should be called the Community Betterment District. Change the name in Council Policy.
- S. Lightner believes the source of revenue is parking meters.
- M. Coakley understand that a garage is very expensive and can not pay for itself.
- K. King against the motion since residents are strongly impacted.
- R. Weiss is against PLJ's control and representation
- R. Thiele encouraged the community leader to vote in favor of the plan. He has been a part of many task forces and the parking problem has been an issue for many years. No is the time for community leaders to come together and find solutions
- M. Mosier there is a parking problem, he has studied parking for many years, the businesses in the village need help, they have been asking for help, it is time to move forward and support the plan.
- O. Gabsch does not want one group in control, the city is the problem.
- PM Lerner does not want the board structure, need balanced control
- Z. Haine doesn't like the veto power
- R. Gashemi was upset that opposition does not want to educate and improve issues in the community.
- R. Weiss agrees that there is a problem but is against it because it is unnecessary.
- P. Metcalf regardless of what comes out of the proposal and advisory board it still has to go through a community hearing process and be approved by City Council. This is the first step in looking at what can be done to resolve problems.

Chair read into the record opposition from E. VanInwegen and Sue Moore received via email.

Chair called for a vote

**VOTE:** 4/5/0 Vote was a tie with Chair Broido voting against to break the tie
